

### OUR FAMILY, FOCUSED ON YOURS

#### **ORGANIZATIONAL OVERVIEW:**

Founded in 1988, Niagara Hospice is a 501(c)(3) health care organization and the only hospice in Niagara County with a New York State Department of Health Certificate of Need. The organization has provided specialized care and personalized support to nearly 27,000 patients, families and caregivers over the last 32 years within Niagara County's population of 210,000.

A member of the National Hospice & Palliative Care Organization (NHPCO) since 1989, Niagara Hospice is the only Western New York hospice that has voluntarily pursued and achieved the ACHC (Accreditation Commission for Health Care) accreditation that demonstrates the organization's commitment to a high level of patient care, operational performance and continuous improvement.

#### **OUR MISSION:**

Niagara Hospice provides specialized care, personalized support and comprehensive guidance to Niagara County patients, families and caregivers facing a terminal illness with a prognosis of six months or less. Patients who receive strictly Medicaid can access hospice care for 12 months or less. We provide expert care and end-of-life support services wherever the patient and family is most comfortable. Niagara Hospice has numerous partnerships with skilled nursing facilities across Niagara County to provide needed services to eligible patients wherever they live.

#### **OUR VISION:**

Niagara Hospice will evaluate each life-limiting diagnosis for hospice eligibility, an important benefit that ensures comfort, dignity and specialized care for terminally ill patients. When Niagara County patients, families and caregivers enter our program, we will provide a customized care plan and personalized support to manage symptoms, deliver caregiver relief and maximize quality of life and precious time together for as long as possible.

#### **THE NIAGARA HOSPICE CAMPUS:**

The administration building, dedicated in February 1996, and the Niagara Hospice House, which features 10 residential long-term care units and 10 general inpatient care units, are located on 25 acres in a serene, rural residential area on the western edge of the Town of Lockport in Niagara County. The mailing address is 4675 Sunset Dr., Lockport, NY 14094.

#### **NIAGARA HOSPICE HOUSE:**

In June 2007, the 24,000-square-foot Niagara Hospice House (4675 Sunset Dr.,

Lockport; 716-280-0600)
opened to provide
general inpatient
care and long-term
residential care. There
are 10 inpatient and 10
residential suites, and
over the last 13 years
our staff has cared for
more than 5,000 Niagara
County families at Hospice
House.



Niagara Hospice maintains collaborative partnerships in Niagara County with Niagara Falls Memorial Medical Center and the McGuire Group that provide dedicated hospice units at two skilled nursing homes - David's Path at Schoellkopf Health Center (621 10<sup>th</sup> St., Niagara Falls; 716-278-4578) that opened in 2014 and Jeanne's House at Northgate Health Care Facility (7264 Nash Rd., North Tonawanda; 716-694-7700) that opened in 2012.

#### **CONTRACTED FACILITIES:**

Niagara Hospice contracts with a variety of other health care facilities to provide hospice services to patients across Niagara County.

#### **COMMUNITY SUPPORT:**

Niagara Hospice benefits from extensive support from community residents and organizations across Niagara County and Western New York. Our special events department organizes special events each year that bring the community together to raise funds for our patients and families, including Spring Bouquet Sale, Jack Beatty Memorial Hospice Cruise & Clambake, Gran Fondo bike ride, Mighty Niagara Half Marathon, Cocktails & Cash raffle and silent auction and Light-a-Life holiday ceremony.

A variety of planned giving options are also available to the public, including bequests of money, real estate or personal property through a will or living trust; retirement plans or life insurance policies that name Niagara Hospice as the beneficiary; gifts that provide lifetime income, such as charitable gift annuities and remainder trusts.

#### COVID-19:

• Since March of 2020, in addition to the changes noted throughout this report, Niagara Hospice has continued to provide essential end-of-life services to patients and families throughout the coronavirus pandemic, while modifying operations to provide maximum infection control and protection.

E'RE ALL IN THIS TOGETHER

STAYING SAFE AT WORK!

- In addition to the 4 negative pressure suites at Hospice House, workplace modifications to the Hospice campus included physical distancing visual reminders, room occupancy limitations, mandatory COVID screening and temperature checks for all visitors and staff, provision of PPE, hand sanitizers and masks (sewn and donated in part by Hospice volunteers) throughout the campus to any and all in need.
- Those personnel who were able to work remotely were encouraged and allowed to do so from the beginning of the pandemic and Governor's state of emergency in March. Upon the implementation of return-to-work protocols and procedures, and the formation of a committee, staff was brought back slowly and safely in July.
- To date, Hospice has reported zero transmission of COVID between or among patients and staff, a track record we hope to continue throughout the pandemic.

#### **RECENT NEWS:**

- Niagara Hospice received a \$90,000 grant from the Mother Cabrini
  Health Foundation to launch a telehealth remote patient monitoring
  program for home care patients across Niagara County.
- The organization received a \$30,000 grant from the Odd Fellow & Rebekah Benefit Fund to enhance the clinical staff's dementia education and multi-sensory caregiving abilities for dementia patients.
- In May, four of the general inpatient rooms at Niagara Hospice House were converted into negative pressure suites to accommodate patients requiring isolation.
- Niagara Hospice acquired new sleeper sofas for all 20 patient suites at Niagara Hospice House in October. The purchase was supported by nearly \$30,000 in proceeds from the 20th annual Jack Beatty Memorial Hospice Cruise & Clambake on July 12.

#### **ADMISSIONS:**

- The organization admitted 923 new patients during the year and cared for 1,092 patients overall, including existing patients at the start of the fiscal year.
- New admissions increased by 86 patients from the previous year.
- The daily patient census reached an all-time high of 205 on April 3.

Volunteers are an essential part of hospice care as they provide a sense of comfort and support to patients, their families, and the staff at Niagara Hospice. This fiscal year:

- 120 volunteers completed 5,706 hours of service
- 2 volunteer training sessions were held
- 8 new volunteers joined our team

Through patient visits, pet visits, vigil team, transportation services, respite for caregivers, friendly visits, Legacy recordings, veteran visits, office and other non-patient related work and special events, Niagara Hospice volunteers provided a cost savings of \$87,998.00 to the

organization during this fiscal year.

We offered one Vigil training for current volunteers who were interested in becoming a part of our Vigil team and supporting our philosophy that "no one should die alone."

We also offered two Enrichment programs that provided an educational experience during this fiscal year.

During the pandemic, many of our volunteer roles had to come to a sudden halt. Volunteer tasks shifted from patient visits to making masks. Instead of being a part of the front line workers they became our behind-the-scenes sewing club. Four volunteers and several organizations made hundreds of cloth masks for staff, patients and families during the COVID-19 pandemic.

A special thank you to our longtime volunteer, Dorothy Socie, who celebrated her 25th anniversary volunteering for Niagara Hospice. Dorothy is one of our administration volunteers who would come in weekly to assemble admission packets. We appreciate what a hardworking and dedicated volunteer Dorothy has been all of these years. Sadly, Dorothy retired from

her volunteer role in June. Thank you, Dorothy, for the countless hours that you selflessly gave to the organization.



## 2019-20 IN REVIEW

#### **SPIRITUAL & BEREAVEMENT:**

This year brought several changes. In March, the Director of Spiritual Care became the Director of Spiritual Care and Bereavement Services. Then the department welcomed two new Spiritual Care Counselors. In the spring, Rev. Tanya Spencer, MVID, MS, co-founder of GLADDD, a girls mentoring program, who has extensive experience, and Dion Greer, with 20-plus years of experience and a year of chaplaincy, joined the team.

Spiritual Care provided support services to 697 patients and family members, while Bereavement provided care to 1,079 family members. Like everyone else we were confronted by the challenges of COVID-19. Spiritual Care Counselors adjusted their schedules, met in people's homes, as well as learned new ways of connecting with patients and their families through FaceTiming, phone calls and visits through doors and windows. Music, pictures, sounds, signs, empathetic listening and genuine compassion enhanced the delivery of services during the pandemic.

The Bereavement Department responded creatively by adding and adapting support methods. We began by switching gears from a live Remembrance Ceremony to a virtual one in June.

This spectacular event took place through the collaboration of the Director and the Bereavement Counselors in conjunction with the PR and IT departments. The theme of "Forget-Me-Not" felt relevant to the atmosphere of the community during the pandemic where people were experiencing intense isolation.

In response to the lack of funeral and burial gatherings, the Bereavement Counselors made more frequent calls. The department added virtual support groups and a closed Facebook page where they could have discussions with one another. Other new initiatives included the launch of an email newsletter, an enhanced bibliography of grief resources and videos on the website, a virtual remembrance ceremony, a grief meditation and yoga for grief.







# KEY DATES IN OUR HISTORY

- 1980 On December 11, the gathering of individuals interested in developing a hospice in Niagara County takes place at the Payne Ave. Christian Church at corner of Payne Ave. and Wheatfield St. in N. Tonawanda.
- 1986 A Certificate of Need is submitted to the NYSDOH (New York State Department of Health) by then board President, Patricia Evans.
- 1988 In June, Niagara Hospice, Inc. is licensed to serve its first home care patients.
- 1996 The newly built Sunset Drive administrative building opens in February under the leadership of Carol Gettings, CEO.
- 1999 Niagara Hospice receives accreditation on June 1 from the Accreditation Commission for Home Care, Inc.
- 2000 Current Niagara Hospice CEO, John Lomeo, is hired in August.
- 2004 The \$3 million "Wings of Serenity" campaign is launched in December to build Niagara Hospice House.
- 2005 The Niagara Hospice Pharmacy Practice residence program becomes accredited in September by the American Society of Health-System Pharmacists. It is the first hospice-based pharmacy practice with an emphasis on home care to receive accreditation in the nation.
- 2006 Construction of Niagara Hospice House on the Sunset Drive, Town of Lockport campus begins in May.
- 2007 First patients admitted to Niagara Hospice

- 2010 In February, Niagara Hospice opens 2 additional residential suites at Hospice House, bringing the total to 10 residential and 10 general in-patient.
- 2012 In March, Hospice at Jeanne's House a
  Northgate and Niagara Hospice Collaboration
  begins serving residents in need of both
  24-hour skilled nursing and hospice services.
  Notably the only collaboration of its kind in
  New York State at the time.
- 2014 On May 28, David's Path renovation is complete and a dedication takes place at Schoellkopf Health Center.
- 2017 In April, Niagara Hospice receives renewed accreditation from the Accreditation Commission for Health Care (ACHC); In June Niagara Hospice House celebrates 10 years of service and in July Niagara Hospice House residential wing named in honor of Paul Beatty, Sr. "Paul R. Beatty, Sr. Residential Suites."
- 2018 In June, Niagara Hospice commemorates its 30th anniversary, having served more than 25,000 Niagara County residents and their families.
- 2020 In May, the Niagara Hospice House converted four of its 10 general inpatient suites into negative pressures suites to accommodate patients with infections.
